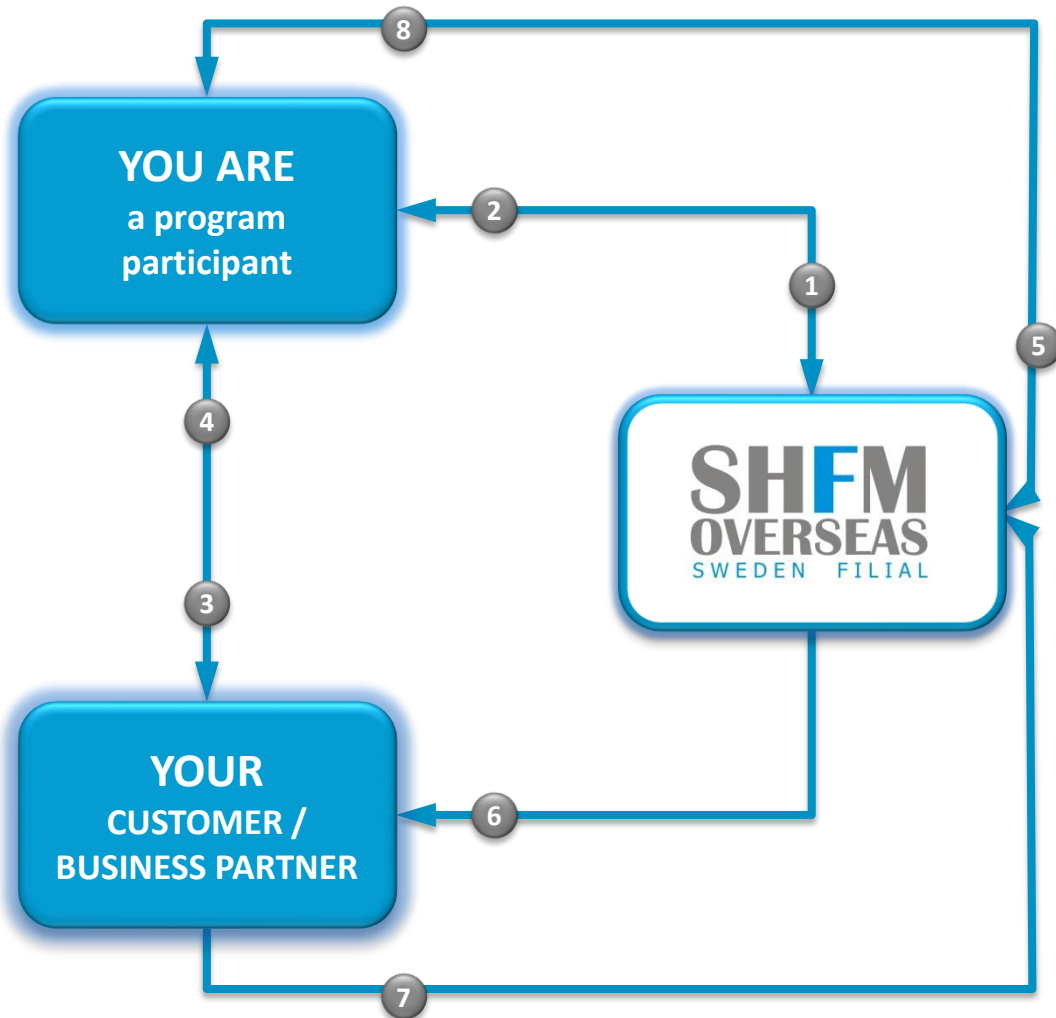

How it works?



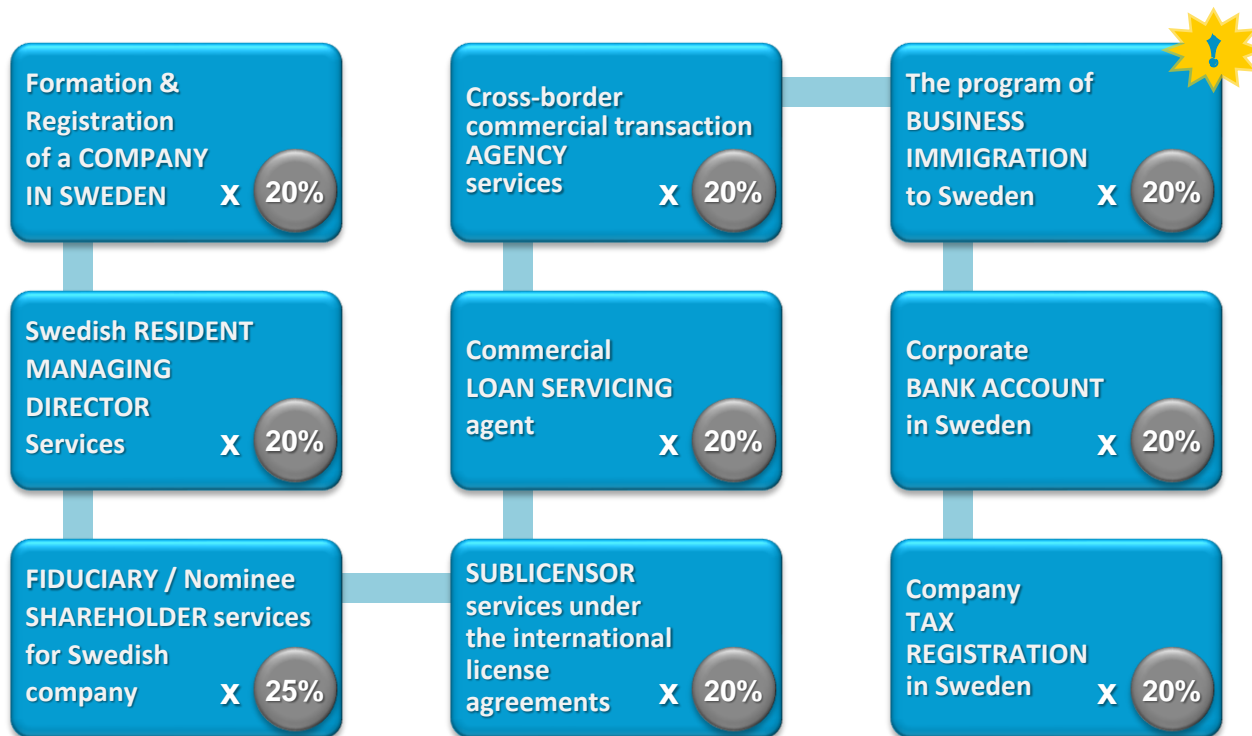
1. You tell us about your desire to participate in the partnership program

Case study:

The customer gives an order and pays for the formation of a **COMPANY in Sweden**:

- 1) Company formation & registration, Aktiebolag (AB)
- 2) Resident managing director services
- 3) Nominee shareholder services for Swedish company



Partner reward:

COMPANY in Sweden = **1,930 EUR lump sum reward**,
upon the invoices paid by the customer

✓ **3-7 customers per annum = 5,790 – 13,510 EUR annually**



Case study:

The customer gives an order and pay for program of **BUSINESS IMMIGRATION to Sweden**:

- 1) Consultation on BUSINESS IMMIGRATION to Sweden
- 2) Company formation & registration, Aktiebolag (AB)
- 3) Obtaining the work & residence permit in Sweden



Partner reward:

The program of BUSINESS IMMIGRATION to Sweden = **2,380 EUR lump sum reward**,
upon the invoices paid by the customer

✓ **5-10 customers per annum = 11,900 – 23,800 EUR annually**
